- 654,706 shares of Common Stock were contributed to Somerset Goods and Services Trust for no consideration.
- By Lucky Liefen LLC. The Reporting Person is the sole manager of Lucky Liefen LLC and, as a result, may be deemed to beneficially own the shares of the Common Stock held by Lucky Liefen LLC. Prager may be deemed to be a beneficial owner of the shares of Common Stock held for the account of the Prager Revocable Trust.

9. By Heorot Power Holdings LLC ("Heorot"). The Reporting Person is the sole manager of Heorot and, as a result, may be deemed to beneficially own the shares of the Common Stock held by Heorot. The Reporting Person disclaims beneficial ownership of such shares of the Common Stock except to the extent of his pecuniary interest therein, and the inclusion of such shares of the Common Stock in this report shall not be deemed an admission of beneficial ownership of all of the reported shares of the Common Stock for purposes of Section 16 of the Exchange Act, or for any other purpose.
