Each restricted stock unit represents a contingent right to receive one share of the Issuer's common stock, \$0.001 par value per share (the "Common Stock").
- On October 16, 2023, the Reporting Person filed a Form 4 which inadvertently reported the total amount of shares of Common Stock owned as 1,298,178. In fact, the total amount owned as of such date following the reported disposition of 205,321 was 1,698,178.
